Important Dates for the School Year 2017/2018

Introduction

Arising from a considerable number of queries the FSSU has been asked to prepare a schedule of important dates in relation to Revenue returns and the preparation and submission of annual financial accounts. The dates listed below for Revenue returns are latest date a return should be filed and paid on ROS i.e. returns can be filed before the 23rd of the month. Also filing frequency varies from school to school i.e. some schools are set up for monthly RCT and P30 returns while others file quarterly returns (every 3 months). The table below includes both monthly and quarterly returns- please select the option which is applicable in your school.
