

Adult Education

Adult Education programmes are currently provided in a number of schools. The board must put in place appropriate procedures and controls to ensure that such courses are operated to the extent that the activity is self-financing. **A separate bank account must be used** for the Adult Education Programme.

The fees should be set at a level to cover all costs other than post of responsibility allowances. These would include costs of tuition, secretarial and caretaking services, lighting, heating, equipment, advertising, etc.

Payments from 1 September 2019 to part-time teachers/trainers/tutors/lecturers

The board may employ tutors for their self-financing evening classes at the rates set out in the Self-Financing Adult Education Classes [Circular 0057/2014](#) and in accordance with Revenue requirements set out below.

Revenue's position is that part-time teachers/trainers/tutors/lecturers are generally engaged under **a contract of service (employee)** as opposed to a contract for service (self-employed). This will apply to all personnel involved in providing evening classes in schools. Therefore, all payments to part-time teachers/trainers/tutors/lecturers must be processed through the school's payroll system.

The financial details of the adult education programme must be accounted for separately in the Board of Management reports and included in the annual accounts to be submitted to the FSSU.

Each school shall make an annual return on the AE Form and the Declaration form to the Department of Education. Please contact the Post Primary Allocations Section at allocations@education.gov.ie if you have any queries on these forms.

The Adult Education Director should comply with the internal controls specified in the 'Governance Manual for Community and Comprehensive Schools'.

Is é seasamh na gCoimisinéirí Ioncaim gurb iondúil go n-oibríonn múinteoirí/oiliúnóirí/teagascóirí/léachtóirí páirtaimseartha **faoi chonradh seirbhíse (fostaí)** seachas faoi chonradh i gcomhair seirbhíse (féinfhostaithe). Beidh sé sin i gceist i gcás an phearsanra uile a mbeidh baint acu le ranganna oíche a sholáthar i scoileanna. Ar an ábhar sin, is gá gach íocaíocht le múinteoirí/oiliúnóirí/teagascóirí/léachtóirí páirtaimseartha a phróiseáil trí chóras párolla na scoile.
