

## Financial Guideline P04 - 2020-2021

### Revised Pay Rates for Board of Management Staff from October 2020

In response to the Department of Education and Skills [Circular 74/2019](#), [Circular 0069/2019](#), and [Circular 0064/2020](#) the following is applicable to staff employed directly by a Board of Management of a recognised school **from 1 October 2020**:

Annualised salaries to be increased by 2% with effect from 1 October 2020 for the following staff:

- Cleaners funded by Ancillary or Capitation grant funding
- Other privately paid staff (For example: Bus Escorts rate per hour will increase from €13.14 per hour to €13.40 per hour)
- Secretaries and Caretakers that are paid on a salary scale that is equivalent to a public services salary scale.
- **This does not apply to Secretaries and Caretakers that are paid on an hourly rate.**

The pay of part-time staff should be revised on a pro-rata basis, in accordance with normal arrangements, by reference to the pay of whole-time staff to which they are related for pay purposes. Please note that the pro-rata pay calculation is based on a whole time equivalent of 39 hours.

- Rúnaithe agus Feighlithe a íoctar faoi láthair ar scála tuarastail atá comhionann le scála tuarastail seirbhíse poiblí. **Ní bhaineann sé seo le Pá Rúnaíochta agus Pá na bhFeighlithe a bhfuil íochta ráta san uair** nó a bhfuil íochta ar scála tuarastail nach bhfuil comhionann le scála tuarastail seirbhíse poiblí
- Baill foirne eile a íoctar go príobháideach (m.sh. coimhdírí bus Beidh rátaí coimhdírí bus ag dul ó €13.14 an uair to dtí €13.40 an uair )

Ba cheart pá ball foirne páirtaimseartha a leasú ar bhonn pro rata, de réir na ngnáthshocruithe, trí thagairt do phá na mball foirne lánaimseartha a mbaineann siad leo ó thaobh pá de. Tabhair do d'aire gur ar choibhéis lánaimseartha 39 uair an chloig atá ríomh an phá ar bhonn pro bunaithe.
