Update to FSSU Chart of Accounts (Revised Version August 2021)

1. Introduction

The chart of accounts has been updated for the year ended 31st August 2021. The chart of accounts is available on the FSSU website, <u>click here.</u> A list of changes is set out in the tables included in Appendix 1 to this guideline.

It is important that the school's chart of accounts is aligned to the FSSU Chart of Accounts and that these codes are not renamed or used for other purposes.

The school's external accountant/auditor will use the revised chart of accounts when preparing the school's annual accounts for year ended 31st August 2021. The FSSU online submission portal for accountants to file the school's accounts is aligned to the revised chart of accounts. Therefore, it is advised to compare the current list of nominal codes in your school's accounts package with this revised chart of accounts to ensure that both are in alignment.
