

Accounting Treatment: Use of the Covid Minor Works Grant for purchase of Non-Capital items

Covid Minor Works Grant - Code 3277 Covid Minor Works should only relate to the proportion of the Covid Minor Works grant that relates to non-capital Covid Minor Works.

For instance, under the Covid Minor Works grant, there is scope to spend monies on items that may not be capital items. Therefore, these items would not be capitalised and are treated as follows:
