

Financial Guideline P14 – 2021/2022

COVID-19 Capitation Funding for Term 2 2021/2022

1. Introduction

The Department of Education has issued notice to schools that COVID-19 Capitation Grant funding for Term 2 of the 2021/22 school year will be issued in early January 2022.

2. Payments to Schools

Grant payments will be calculated using the same per capita rates as applied for the 2020/21 school year and will be based on recognised enrolments for September 2020. The rate is adjusted to reflect that Term 2 is shorter than Term 1.
