

## Financial Guideline P12 - 2021/2022

### **Enhanced Minor Works Grant Funding for Primary Schools with a particular focus on supporting enhanced ventilation (Circular 65/2021)**

#### **1. Introduction**

The purpose of this guideline is to provide details of the Minor Works and the Enhanced Minor Works Grant Funding for primary schools in continuing to support the operation of schools generally and particularly within a Covid-19 environment, with a specific focus on providing additional support to schools for the implementation of the ventilation guidance published by the Department in May 2021.

The payment of these grants at this stage gives schools the opportunity to undertake any minor works including ventilation improvements at school level as a matter of priority. The minor works grant funding provides good flexibility to address issues at local school level and to take a targeted approach. Schools need not apply to the Department for approval to carry out works or to purchase items to improve ventilation. Larger scale works (beyond the level of this enhanced funding) can be addressed under the Department's Emergency Works Scheme.

This guideline should be read in conjunction with Circular 0062/2013 "Grant Scheme for Minor Works to National School Properties" and the Department's document "Practical Steps for the Deployment of Good Ventilation Practices in Schools". Given that each school setting is different, individual schools are best placed to decide on the appropriate measures for their school and have flexibility in this regard. For instance, the funding also provides an opportunity for schools to enhance their outdoor learning environments for use as the weather permits.

Given that there is no one solution that fits all scenarios, schools may seek specific technical specialist advice/assistance of a Chartered Engineer or Registered Architect to advise on appropriate measures to take for enhancing ventilation. An Engineer or Architect who is currently, or has previously, worked on a project at the school may be well placed to give a school some initial advice on ventilation matters. This may include advice on the appropriate HEPA Air Cleaner unit as an additional measure in conjunction with other methods of ventilation that are available, which is matched to the specific room size, volume and existing ventilation arrangements in circumstances where poor ventilation continues to exist in a particular room/area after the recommended measures in the Practical Steps have been applied. Specialist advice/assistance of a Chartered Engineer or Registered Architect is an important source of support for schools.

The HEPA Air Cleaner Technical Guidance in Appendix 1 in the Room Air Cleaner Guidance document available at <https://www.gov.ie/en/publication/ad236-guidance-on-ventilation-in-schools/#room-air-cleaners> is particularly relevant here.

A dedicated team has been established in the Department of Education to support schools that may have concerns about ventilation. The team is also available to contact schools where required, walking through the steps that schools should take to deploy good ventilation practices etc. Where it is not possible for a school to access the expertise of an engineer or architect, and where necessary, a technical assessment to assist the school can be facilitated through the Department.

### 3. Minor Works Grant Payment

The table below provides an illustrative example of the value of the Minor Works Grant for primary schools of various sizes.

#### **4. Administration**

The grant will be paid directly into the school bank account. The payment will be made in two tranches: the standard MWG paid first (Table 1) and the Enhancements to MWG funding subsequently (Table 2). It is envisaged that all payments will be processed in December 2021.

As with all exchequer grant-aid, school authorities should maintain detailed records on how funding, provided under this scheme, was spent. If there is any unused funding this should also be recorded.

Where there is insufficient funding to address specific ventilation enhancements, schools can address this through the Emergency Works Scheme, which is available at <https://www.gov.ie/en/circular/97829-emergency-works-grant-scheme-migration-to-online-applications-and-minor-revisions-of-scheme/>

Schools are required to adhere to procurement regulations and appropriately record costs paid from the grant received. A Chartered Engineer or Registered Architect can provide assistance to schools on procurement where required.

The payment of the grant at this time provides the opportunity to schools to undertake any minor works including ventilation improvements as a matter of priority. Schools, on request, must be in a position to provide the Department with a written statement of the expenditure of the grant (which may be subject to compliance checks by the Department) and also a record of any unused funding. The treatment and arrangements in respect of any unused funding will be notified to schools by the end of 2022.

#### **5. Recording the grant income and expenditure in school accounts**

The existing Minor Works and Covid Minor Works Grant Income and Expenditure codes can be used to record the income and expenditure. These codes are set out in the tables below:

## Treoir Airgeadais P12 – 2021/2022

### Cistiú Breisithe i gcomhair An Deontais Mionoibreacha le haghaidh Bunscoileanna agus fócas faoi leith aige ar thacaíocht don aeráil feabhsaithe (Ciorclán 65/2021)

#### 1. Réamhrá

Is é cuspóir na treoirlíne seo ná sonraí a sholáthar maidir leis an gCistiú i gcomhair An Deontais Mionoibreacha agus maidir leis an gCistiú Breisithe i gcomhair An Deontais Mionoibreacha le haghaidh Bunscoileanna mar chuid den tacaíocht leanúnach d'fheidhmiú scoileanna i gcoitinne agus go háirithe i dtimpeallacht Covid-19, agus fócas faoi leith ar thacaíocht bhreise a sholáthar do scoileanna i dtaca le cur i bhfeidhm na treorach aerála arna foilsiu ag an Roinn i mí na Bealtaine 2021.

Tugann íocaíocht na ndeontas seo ag an bpointe seo an deis do scoileanna tabhairt faoi aon mhionoibreacha lena n-áirítear feabhsúcháin aerála ar leibhéal na scoile mar ábhar tosaíochta. Tríd an gcistiú deontas mionoibreacha soláthraítear solúbthacht mhaith chun aghaidh a thabhairt ar fhadhanna ar leibhéal na scoile áitiúla agus chun cur chuige dírithe a ghlacadh. Ní chaithfidh scoileanna faomhadh a lorg ón Roinn chun oibreacha a dhéanamh ná chun earraí a cheannach le haghaidh feabhas a chur ar an aeráil. Is féidir tabhairt faoi oibreacha ar scála níos mó (níos faide ná leibhéal an mhaoinithe fheabhsaithe seo) faoi Scéim Oibreacha Éigeandála na Roinne.

I bhfianaise go bhfuil gach suíomh scoile éagsúil, is ag an scoil aonair is fearr a bheidh an rogha cinneadh a dhéanamh i dtaca leis na bearta iomchuí don scoil féin agus beidh solúbthacht aici dá bharr. Mar shampla, leis an gcistiú tugtar an deis do scoileanna feabhas a chur ar na timpeallachtaí foghlama lasmuigh le haghaidh úsáide má bhíonn an aimsir in araíocht dó.

I bhfianaise nach ann do réiteach amháin atá oiriúnach i ngach cás, is féidir go gcuardóidh scoileanna sainchomhairle/cúnamh speisialaithe teicniúil ó Innealtóir Cairte nó Ailtire Cláraithe chun comhairle a thabhairt maidir leis na bearta iomchuí atá le glacadh chun an aeráil a fheabhsú. D'fhéadfadh Innealtóir nó Ailtire atá ag obair faoi láthair ar thionscadal sa scoil, nó a d'oibrigh roimhe seo air, a bheith feiliúnach chun réamhchomhairle a thabhairt do scoil ar ábhair aerála. D'fhéadfadh go n-áireofaí air sin comhairle maidir leis an aonad iomchuí de Ghlantóir Aeir HEPA mar bheart breise i dteannta le bearta eile aerála atá ar fáil a oireann do shainmhéid an tseomra, don toirt agus do na socruithe aerála atá ann cheana i gcásanna ina bhfuil droch-aeráil fós i seomra/limistéar faoi leith tar éis do chur i bhfeidhm na mbeart molta sna Céimeanna Praiticiúla. Is foinse thábhachtach tacaíochta do scoileanna comhairle/cúnamh speisialtóra Innealtóra Cairte nó Ailtire Cláraithe.

Tá an fhoireann ar fáil freisin chun teagmháil a dhéanamh le scoileanna más gá, ag dul trí na céimeanna ar chóir do na scoileanna iad a thógáil chun feidhm a bhaint as deachleachtas aerála etc. Murar féidir le scoil teacht ar shaineolas innealtóra nó ailtire, agus más gá, is féidir measúnú teicniúil a éascú trí an Roinn chun cúnamh a thabhairt don scoil.

#### **4. Riarachán**

Íocfar an deontas seo go díreach isteach i gcuntas bainc na scoile. Déanfar an íocaíocht in dhá sciar: ar dtús íocfar an Deontas Mionoibreacha caighdeánach (Tábla 1) agus tar éis sin íocfar an cistíú i gcomhair Feabhas ar an Deontas Mionoibreacha (Tábla 2). Samhlaítear go bpróiseálfar gach íocaíocht i mí na Nollag 2021.

Mar is amhlaidh i gcásanchúnaimh deontais uileón státhiste, ba cheartd'údaráis scoile taifid mhionsonraithe a choinneáil maidir leis an tslí a caitheadh an maoiniú a soláthraíodhfaoin scéim seo. Más ann do mhaoliniú nár baineadh feidhm as, is ceart é sin a thaifeadadh freisin.

Ní foláir do scoileanna cloí le rialúcháin soláthair agus taifead a dhéanamh mar is ionchuí ar chostais a íocadh ón deontas a fuarthas. Is féidir le hInnealtóir Cairte nó le hAiltire Cláraithe cúnamh a sholáthar do scoileanna maidir le soláthar nuair is gá.

Tugann íocaíocht an deontais ag an bpointe seo an deis do scoileanna tabhairt faoi aon mhionoibreacha lena n-áirítear feabhsúcháin aerála ar leibhéal na scoile mar ábhar tosaíochta.

Ní mór do scoil bheith in ann ráiteas scríofa maidir le caiteachas an deontais (a d'fhéadfadh bheith faoi sheiceáil chomhlíontachta na Roinne) agus taifead ar aon mhaoiniú nár baineadh feidhm as a sholáthar don Roinn, arna n-iarraidh sin uirthi. Cuirfear scoileanna ar an eolas maidir le láimhseáil agus socrutithe i dtaobh aon mhaoiniú nár baineadh feidhm as roimh dheireadh 2022.
