

Revision of Schools Support Services Grant Rates and Summary of Interim Arrangements for the Payment of Ancillary-Related Grants (January to August 2026)

1. Introduction

[Circular 0030/2026](#) outlines the revised per capita rate applicable to the Schools Services Support Fund (SSSF) grant allocated to Voluntary Secondary Schools in the Free Education Scheme for 2026. This guideline outlines the rate increases below.

The Department of Education and Youth has issued a notice to advise schools of the arrangements for the payment of ancillary-related grant funding, including SSSF and Secretary Grants for the period January to August 2026. 2. Rate Adjustment

[Circular 0030/2026](#) advises the Schools Services Support Fund (SSSF) grant rate has been increased effective from January 2026 to cater for the introduction of the State-sponsored retirement saving scheme MyFutureFund.

3. Grant Rates Applicable

	Grant Type	Rates	Details
a)	School Services Support Fund (SSSF)	€227.90	The SSSF grant is increased from €224.50 to €227.90 per pupil. The grant is calculated at a minimum enrolment of 200 pupils and thereafter according to enrolment.
b)	Basic Secretarial Grant	€40.60	The grant is increased from €40.00 to €40.60 per pupil. The grant is calculated by multiplying the enrolment figure by the rate up to a maximum of 350 pupils.

			Schools employing secretaries under ‘the 1978 scheme’ do not receive any secretary grants.
c)	SSSF Secretary Grant	€26.90	The grant is increased from €26.50 to €26.90 per pupil. The grant is calculated by multiplying the enrolment figure by the rate up to a maximum of 350 pupils. Schools employing secretaries under ‘the 1978 scheme’ do not receive any secretary grants.
d)	Basic Caretaker Grant	€34.50	The grant is increased from €34.00 to €34.50 per pupil. The grant is calculated by multiplying the enrolment figure by the rate up to a maximum of 350 pupils.
e)	SSSF Caretaker Grant	€20.80	The grant is increased from €20.50 to €20.80 per pupil. The grant is calculated by multiplying the enrolment figure by the rate up to a maximum of 350 pupils.

4. Interim Arrangements for the Payment of Ancillary-Related Grants

The Department of Education and Youth has issued a notice to advise schools of the arrangements for the payment of ancillary-related grant funding, for the period January to August 2026. [Click here](#) for copy of notice. Grant payments will issue to schools in the coming days.

There are two categories of schools, each with different arrangements.

- I. Schools with a secretary who transferred to the Department’s payroll since September 2023
- II. Schools that do not employ a secretary on the Department’s Payroll

5. Schools with a secretary who transferred to the Department’s payroll since September 2023

Where a secretary was previously paid from grant funding and this secretary transferred to the Department’s payroll since September 2023, the Department requested details of the annual salary and employers PRSI costs that the school had been paying.

This salary information will be used to adjust(reduce) ancillary – related grants for the period January – August 2026.

➤ The interim grant payment will be calculated as follows;

As confirmed previously, no reduction will be made to capitation grant funding.

6. Schools that do not employ a secretary on the Department's payroll

This applies to:

- Schools with no secretary, or
- Schools with a secretary who has not transferred to the Department payroll since September 2023.

For these schools, grants will be calculated as normal, with no reductions.

7. Reminder on Recruitment Rules

From **13 June 2022 onwards**, new or replacement secretaries recruited must be employed by schools on the new terms and conditions as set out in [Circular 36/2022](#) and [Info Note ESR 02/2023](#).

8. Future Grant Arrangements

Grant adjustments may change if:

- A school secretary joins the Department's payroll during the year, or
- There is a significant change in hours worked.

Work is ongoing to identify a method of standardising the reduction to the ancillary-related grants for the longer term where school secretaries are being paid on the Department's payroll. The current payments may vary when a permanent model for ancillary-related grant reductions has been finalised. Engagement will take place with school management bodies in order to discuss these arrangements to ensure that they are as reasonable and as fair as possible for all schools.

Further details will be issued to schools once finalised.
