#### **1. Introduction**

Where students in special schools are involved in the state exams and payments are made to school appointed personnel, this guideline outlines the rates of pay and the refund procedure schools must follow.

Schools are required to:

- arrange payment to school appointed personnel engaged in examinations roles.
- maintain records of these activities; and
- collect receipts from those paid to facilitate claiming payment for SEC in due course.

At the end of the examination period, schools should claim the costs incurred for the State Examinations 2026 from the SEC, to include the Examination Aides, all school appointed Superintendents, Examination Attendants, payment for preparatory work and assessment of projects, miscellaneous expenses and transport costs associated with Oral Examinations at Easter.

**Please note that claim forms will not be posted out to schools this year by the SEC.**

[SEC Circular S17/26](#) advises of the payment arrangements, including rates of payment, which will apply for school appointed personnel and other additional costs for Examinations 2026.

The circular should be read in conjunction with SEC Circulars: [Circular S86/25](#) – *Leaving Certificate 2026 – Preliminary Information on the Oral Examinations in Irish & Modern Foreign Languages*, [Circular S18/26](#) – *Leaving Certificate (Established) Examinations 2026; Oral Examinations in Irish and the Modern Foreign Languages*, [Circular S14/26](#) - *RACE - Interim Additional time arrangements at the 2026 State Examinations* and other circulars relating to the conduct of the examinations.

## 2. Refunds to Schools

The State Examinations Commission (SEC) will refund the costs in respect of the following, where appropriate:

- a) Examination Aides Days
- b) Examination Aide – Pastoral Support for Leaving Certification Oral examinations at Easter
- c) Designated person for Visual Impaired Candidates
- d) School appointed Superintendents for the Day Practical tests in Leaving Certificate Construction Studies, Engineering and Art, the final examinations in May in LCVP Links Modules, LCA ICT and Leaving Certificate Computer Science and as required for the Aural Examinations in June.
- e) School appointed Superintendents for special examination centres
- f) Examination Attendants
- g) Miscellaneous Expenses associated with schools open during Easter holidays to facilitate the 2026 Leaving Certification Oral Examinations
- h) Transport costs associated with candidates travelling to school for examinations over Easter holidays
- i) Payment for preparatory work/assessment of projects.

## 3. Application of Tax, PRSI and USC

School appointed personnel associated with running the state examinations must be registered with ROS and the payment processed through the school's computer payroll package. It is the responsibility of individual schools to administer tax, PRSI and USC for the above appointments and to pay over any monies deducted in respect of same to the Revenue Commissioners.

The appointment of school personnel for the examinations is covered under **Class J PRSI**. This is because state examination work is subsidiary employment. This will need to be confirmed under the employee's details in the payroll package. The rate of employer PRSI under this class is 0.7%.

The SEC will refund to schools the employer PRSI at the appropriate rate.

Payments are exempt from the Additional Superannuation Contribution (ASC).

In order to ensure that the payroll can be processed in a timely manner, it is advisable that the following details are received from each employee on commencement of their duties:

- Name
- Address
- Date of Birth
- PPS Number
- Commencement date
- Bank account details – Account BIC & IBAN

For attendants it may be their first employment. They will need to register the employment as soon as possible to avoid paying emergency tax. To do this, they must register for '[myAccount](#)' with Revenue. When they receive the '[myAccount](#)' password they will be able to register the employment with the school. In order to do this, you will need to provide them with the school's employer registration number. When they have registered the employment, Revenue will make a Revenue payroll notification (RPN) available to the school.

#### **4. My Future Fund Auto-Enrolment Retirement Savings Scheme**

The SEC will refund to schools the employer contribution for those automatically enrolled by NAERSA at the appropriate rate in respect of school appointed personnel. In the first year the employer will pay 1.5% and employee will pay 1.5%.

The employer expense incurred should be included in the Overview Form 2026 and supporting documentation should be included to support the claim.

Supporting documentation can be in the form of print outs or screenshots from the NAERSA portal or a report from the payroll system. Any information included on the documentation not relevant to the claim, e.g. personnel not involved in exams or payroll taxes and net pay amounts should be redacted.

## 5.Rates of Payment 2026

### (i) Examination Aides

Examination Aides Rate per Day	€172.60

As per [SEC Circular S17/26](#), the number of Examination Aide days available will depend on the number of candidates in the school and the range of activities that are required to meet the needs of candidates in that school, as follows:

#### a. General

**(ii) School appointed Superintendents, including Special Centre Superintendents, for the day practical examinations in Construction Studies, Engineering and Art, LCVP Links Modules, Leaving Certificate Computer Science and LCA ICT examinations in May, and additional centres required for Aural Examinations for Leaving Certificate, Leaving Certificate Applied and Junior Certificate.**

Other than the Aural Examinations in June, the other listed examinations are taking place in schools on school days. Details of the particular examination arrangements that will apply will be the subject of separate SEC communications which will issue prior to the commencement of these examinations.

The rate of payment for individuals appointed as Superintendents and Special Centre Superintendents for the examinations in 2026 are as follows:

**(iii) School Appointed Superintendents for Reasonable Accommodations**

The rates for school appointed superintendents for reasonable accommodations (which include the duties of Reader and/or Scribe) for special centres for the 2026 examinations are as follows:

School appointed Superintendent (Non-SNA Rate)	€71.07 per session
School appointed Superintendent (SNA Rate)	€54.23 per session

Where the school appoints a local Superintendent and that Superintendent is a Special Needs Assistant, specific payment arrangements apply. The Department of Education and Youth has an agreement with the trade Union FORSA, which represents SNAs, that in cases where an SNA is supporting a candidate in a special centre during the examinations and also performing the duties associated with superintending of the special centre, the agreed fee, will be paid to the SNA in respect of the superintending role.

**(iv) Examination Attendants**

Student attendants, nominated by schools, assist the Superintendents throughout the examinations.

**Main Examination Centres:**

Attendants should be appointed on the basis of one attendant per main examination centre.

**Special Examinations Centres -Shared Only**

On application, the SEC may authorise the appointment of a shared attendant for shared special examination centres as follows;

- one attendant for every two shared special centres provided there are 6 candidates or more between the two centres.

School authorities must apply for approval for these posts from RACE section by e-mail to [race@examinations.ie](mailto:race@examinations.ie).

The SEC will not fund the cost of attendants assigned by schools to individual special centres. Should a school assign attendants to individual special centres they will be required to meet this cost from their own resources.

Payments to attendants should be processed through the school payroll and costs recouped from

the SEC, at Class J or Class M for those under age 16. It is likely emergency tax rates will apply if the attendant has not previously registered with Revenue. To avoid this, attendants should register for Revenue's ['myAccount'](#) now and register the school as their employer.

Please provide attendants with the school's employer tax registration number for them to be able to do this. Any taxes that may be deducted, where they have not registered can be reclaimed by the attendant logging on to their Revenue's MyAccount and selecting 'Claim unemployment repayment' on the PAYE services card.

The Attendant timesheet will specify the rates applicable.

**Note** If Employer's PRSI of 0.7% (Class J) is paid, this should be written on to the end of the form and added to the refund being claimed.

**(v) Miscellaneous Expenses**

The SEC will consider claims from schools and other exchequer funded settings for reasonable additional costs specifically incurred to ensure school opening at Easter, subject to the qualification below:

Miscellaneous Expenses	Guide
Heating/Lighting	Based on a reasonable proportion of amenity bills for the duration of examinations and the number of examination sessions held in the school over the <b>Easter holidays</b> .
Caretaking/Cleaning	Based on agreed rates of pay in the school to cover Examinations held in the school over the <b>Easter holidays</b> .

**(vi) Transport for some candidates travelling to schools for examinations over the Easter holidays**

Schools are asked to facilitate the attendance of candidates for examinations over the Easter holidays, using taxi services in the following limited circumstances. The candidates must be:

- eligible for school transport under the terms of the Department’s School Transport Scheme
- be availing of school transport in the current school year and
- be required to attend for the Oral examination event over this period.

The SEC will reimburse schools for reasonable costs of such services on the production of valid receipts.

Note: For the Deferred Leaving Certification examination, candidates are required to meet their own costs.

**(vii) Preparatory Work/Assessment of Projects for State Examinations**

- Teachers who undertake preparatory work and assessment of projects for the State Examinations in schools, where applicable.
- Please note that only one payment per candidate per subject can be claimed.  
Schools should arrange to pay teachers directly through the school payroll for this work and the cost can be recouped as part of the school claim from the SEC.
- Preparatory work and assessment of projects are limited to the following subjects at the rates specified:

**6. Advance Payments to Schools**

To assist with defraying some of the costs associated with the 2026 State Examinations, the SEC will provide an advance payment to schools in May 2026 for Examinations 2026, in line with the normal practice. The advance will be offset against the final school 2026 claim.

**7. Claims for Reimbursement**

All documentation relating to payments to school appointed personnel for examinations 2026 should be retained by schools during the examination process.

**All claims are to be held and sent together in one submission at the end of all activities relating to examinations 2026.**

All claims for reimbursement **must be made on the appropriate SEC forms.**

The composite [Overview Form OS 2026](#) must be completed and returned with all completed individual claim forms to:

The use of non-SEC claim forms will result in the entire claim being returned to the school. All claims for reimbursement must be signed by the recipient in the school and the school Principal. Claims that are completed incorrectly, inaccurately and /or unsigned will be returned in their entirety to the school.

**8. Accounting for State Exam Income**

The income and associated expenditure should be recorded appropriately in the school's accounts. The nominal codes used to record receipt of the State Exam Income and related expenditure are as follows:

- taifid a choinneáil ar na gníomhaíochtaí sin; agus
- fáltais a bhailiú uathu siúd a íocadh, le go mbeadh sé níos éasca íocaíocht le haghaidh SEC a éileamh níos déanaí.

Ag deireadh thréimhse na scrúduithe, ba cheart do scoileanna na costais a tabhaíodh do Scrúduithe Stáit 2026 a éileamh ar Choimisiún na Scrúduithe Stáit, lena n-áirítear na Cúntóirí Scrúdaithe, gach Feitheoir arna cheapadh ag an scoil, Maoir Scrúdaithe, íocaíocht as réamhobair agus measúnú ar thionscadail, costais ilghnéitheacha agus costais iompair a bhaineann leis na Scrúduithe Béil in aimsir na Cásca.

## **3. Feidhmiú Cánach Ioncaim, MSU agus ÁSPC**

Ní mór do phearsanra arna cheapadh ag an scoil a bhfuil baint acu le reáchtáil na scrúduithe stáit a bheith cláraithe le ROS agus an íocaíocht a phríoiseáil trí ríomhphacáiste párolla na scoile. Tá freagracht ar scoileanna aonair as cáin ioncaim, ÁSPC agus MSU a riar i gcás na gceapachán thuasluaite agus aon airgead a asbhaintear ina leith a íoc leis na Coimisinéirí Ioncaim.

Clúdaítear ceapachán pearsanra scoile le haghaidh scrúduithe faoi **ÁSPC Aicme J**. Is é is cúis leis sin ná gur fofhostaíocht í an obair ar scrúduithe stáit. Caithfear é seo a dheimhniú faoi shonraí an fhostaí sa phacáiste párolla. Is é ráta ÁSPC an fhostóra faoin aicme seo ná 0.7%.
